(hereinafter referred to as: the signatories)

conclude the following

AGREEMENT ON CO-OPERATION IN THE FIELDS OF EDUCATION AND SCIENCE AND RESEARCH

Article 1

The signatories agree that the purpose of this Agreement is to establish mutual co-operation in the fields of education and science and research, with the two fields facilitating development, good understanding between nations and long-term international co-operation.

Article 2

In order to realize the set objectives and tasks, the signatories agree that the co-operation will be carried out in accordance with regulations valid in the countries of the signatories and in accordance with regulations and criteria adopted by the signatories of this Agreement.

Article 3

The co-operation will be based on providing support to activities that will be in the interest of both the signatories, i.e.:

- Exchange of experience in the fields of education and science and research;
- Co-operation in the formation of new study programs and in the realization of joint research and professional projects;
- Possible co-operation in field of publishing joint publications and textbooks, as well as co-operation related to the existing publications;
- Organization of meetings, seminars, discussions and other scientific and professional meetings on topics that will be of interest to both the signatories;
- Enhancement of the education process by facilitating mobility of the academic and research staff and students;
- Enabling the academic and research staff and students of both the signatories to use the library holdings of both the signatories.

Article 4

Organizational, financial and other questions related to all forms of co-operation ensuing from this Agreement will be settled either on the basis of a programme of co-operation between the members or universities or by an annexe to this Agreement or in some other suitable way.



Article 5

In order to realize individual activities as stipulated by Articles 3 and 4 of this Agreement, the signatories agree to make common efforts to provide financial resources and other forms of co-operation with national, research, economic and other institutions registered in the countries of the signatories.

Article 6

The expenses ensuing from this Agreement will be covered by the signatories as follows:

- Visits and exchanges – the signatory that sends its delegation to visit the other signatory will cover all expenses arising from the visit of its delegation;
- All other forms of co-operation – the expenses arising from all other activities will be subject to further agreements between the signatories in accordance with regulations of the individual institutions.

Article 7

This Agreement is concluded for an unspecified period of time, and becomes binding on the date when signed by the authorized persons of both the signatories.

Article 8

Each signatory is entitled to a unilateral breach of the Agreement at any time if the Agreement does not facilitate the realization of the objectives for which it has been concluded and on condition that the withdrawing signatory has bound itself to conclude the ongoing projects and has covered its financial obligations as ensuing from this Agreement.

Article 9

All further changes to this Agreement will be agreed upon in an Annexe signed by both the signatories and forming an integral part of this Agreement.

Article 10

This Agreement is signed in four (4) identical copies, two in Slovenian and two in English language, of which each signatory receives two (2) copies.
